

CHECKLIST FOR IDENTIFYING RISKS OF CONFLICT OF INTEREST IN ORGANISATIONAL FUNCTIONS

The purpose of this tool is to assist you in identifying conflicts of interest risks in your organisation. The checklist sets out organisational functions identified by integrity agencies as presenting conflicts of interest risks. Use the checklist as part of your environmental scan when preparing your conflicts of interest policy. Where your organisation performs one of the functions listed below, you should identify the specific risks for your organisation and check that your policy provides appropriate management strategies.
